Option 1: ABR Membership

You may choose to use the Automatic Billing Request (ABR) system whereby \$2 is charged to your account for every unit shipped from the manufacturers of Kawasaki or Suzuki, plus \$500 if any other lines are carried.

Option 2: Fixed Dues Membership

This method is designed for exporters and dealers selling American or European bikes. The annual dues are \$1,000.
