The International Aesthetic and Laser Association (IALA) was formed in 2008 as a nonprofit professional association that includes providers of laser hair removal and other cosmetic services throughout the United States, Puerto Rico and Canada. As providers of these services, we are concerned that state legislatures and other regulatory bodies are adopting inconsistent and sometimes unnecessary standards to govern our industry. Since our members provide more of these services than any other group or entity, we believe it's important that we influence the creation of these standards for the safety of consumers and so that our services remain affordable and widely available to the public.

Since our formation, IALA has organized a Training and Certification Committee that has created an industry-leading certification program for operators of laser hair removal devices. Our Regulatory and Legislative Advocacy Committee is monitoring legislation and regulation in all member states. Our Consumer and Public Education and Awareness Committee and Research Committee are responsible for developing and disseminating data to enhance public awareness and understanding of laser hair removal, including types of services, technologies, effectiveness, risks, certifications of treatment professionals, and advances in the industry. And, our Membership Committee is seeking others who share our commitment to the promotion of laser hair removal.

Certified Laser Hair Removal Provider

IALA has joined with the National Council on Laser Excellence (NCLE) to provide Laser Certifications of the highest standards for both Laser and IPL based hair removal. IALA Laser Hair Removal Certification is available to all those who meet the educational and experience requirements, and who pass a proctored examination. Applications and information are available at **LaserCertification.org** in the "Candidate Handbook." The NCLE is a credentialing board of the non-profit Professional Medical Education Association which was established in 1978, and the credentialing board has offered Medical Laser and Hair Removal Certifications since 2000.

The IALA Training and Credentialing committee has developed a comprehensive and standardized Laser Hair Removal Training Outline and Objectives that is available free of charge to anyone wishing to provide an IALA and NCLE Laser Certification compliant training program. All IALA members adhere to the high standards of these objectives.

Laser Hair Removal Courses

IALA has joined the Laser Training Institute to offer joint workshops in Laser Hair Removal. These three day programs meet all the requirements of the Standardized Training Outline and qualify the individual to sit for the Laser Hair Removal Certification examination. These courses include a Laser Certification Review and administration of the exam on the last afternoon of the course.

Model Legislation

IALA has developed recommended model legislation for State Legislatures that specifically and succinctly addresses issues with public safety, standardized training, and certification of providers for laser / IPL Hair Removal.

At this time, our membership includes owners and operators of more than 500 members in 42 states. Together we employ hundreds of physicians, nurses, other medical professionals, estheticians and other trained persons who deliver more than two million laser hair removal procedures annually. IALA members are committed to delivering laser hair removal and other cosmetic services safely and effectively following using the best technology and best trained eople following tried and tested protocols.
